- Michigan encodes their driver's licenses using magnetic stripe. MI encodes a limited amount of data that allows our Age Verifier to perform all necessary validation checks, and create a log to prove patrons IDs were carded. The name and address are not encoded. Our Model 2000S-800 CAN read the front of the ID, perform age verification or IDAutoFill, and capture the name and address. This holds true for all State IDs.
- Illinois encrypts part of their PDF-417 bar code label. In addition to the basic LOG data, the age
 verifier also captures and stores the cardholder's Name. No other personal data is stored in the
 LOG File or the ALL File. To capture the Name, you must configure the Age Verifier's Data
 Storage to "ALL". If you want to capture the address you must use our Model 2000S-800.
- Alaska has recently started encoding driver's licenses using the PDF-417 barcode label. It will be a period of time before all licenses will be 'readable'.
- 4. Florida now issues Driver's Licenses with PDF-417 Barcode & Magnetic Stripe encoding.
- The magnetic stripe on the Missouri Driver's Licenses is not encoded. The newer Missouri Driver's License has a readable PDF-417 Barcode encoded.
- 6. Georgia's current Driver's License 'front side' can only be read using our Model 2000S-800.
- 7. Minnesota's newest DLs PDF-417 Barcode data does not include an Expiration Date, or address. The magstripe does. For more secure age verification, we recommend you scan the barcode. You can scan the DLs magstripe ("If the model has a magstripe reader") to verify, and capture the age, expiration date, name, address, and other useful information. If you need the address, but not age verification, then our Model 2000S-800 may be appropriate.
- Alabama's DL barcode data encoding includes Name, Street Address, City, and State.
 The new AL driver's license does not include the zip code. Our 2000S-800 may be appropriate.
